## **Change in Status of Other Affiliated Company**

TonenGeneral Sekiyu K.K. (head office: Minato-ku, Tokyo; president: Jun Mutoh; "TonenGeneral" herein) announces a change in status of one of its other affiliated companies as follows.

#### 1. Background of change

The transaction announced on December 18, 2013, in which 36 million (9.99% of total number of shareholder voting rights) of the 80 million shares of TonenGeneral stock owned by Exxon Mobil Corporation (head office: Texas, U.S.A.; "ExxonMobil" herein) through Exxon Mobile Bay Limited Partnership were to be transferred to Mitsui & Co., was completed today. After the transaction, Exxon Mobil Bay Limited Partnership will own 44 million shares of TonenGeneral stock and hold 12.21% of shareholder voting rights. Thus, as of today, Exxon Mobile Bay Limited Partnership will cease to be an "other affiliated company" of TonenGeneral.
