Notice Regarding Joint Venture

TonenGeneral Sekiyu K.K. (head office: Minato-ku, Tokyo; president: Jun Mutoh; herein referred to as "TonenGeneral Group" including its affiliated company(ies)) has entered into an agreement with Union Carbide Corporation, to purchase its 50% share interest in Nippon Unicar Company Limited (head office: Shinagawa-ku, Tokyo; president: Keiki Satoh; herein referred to as "NUC"), a 50/50 joint venture between TonenGeneral Group and Union Carbide Corporation, a wholly owned subsidiary of The Dow Chemical Company (head office: Midland, Michigan, USA; chairman and CEO: Andrew N. Liveris); subsequently dissolving the joint venture and making NUC a wholly owned company of the TonenGeneral Group. Finalization of the purchase is planned for third quarter 2013, pending receipt of all required regulatory approvals.

The TonenGeneral Group anticipates that this purchase will be a step towards achieving the integrated manufacturing and sales operations envisioned at the time of the June 2012 formation of the new TonenGeneral Group. NUC's operations, as a result, will be optimized from feedstock procurement through the polyethylene manufacturing process enabling optimal operations for more prompt, flexible response to market needs.

The NUC brand name is familiar to polyethylene customers with its wide range of polyethylene products. Above all, NUC's high voltage electric wire and cable insulation products are technologically advanced products with superior competitive advantage in the Japanese and other markets. The TonenGeneral Group plans to further develop those segments of NUC's business into a mainstay of its chemical division by enhancing domestic sales while actively promoting the NUC brand overseas.

The financial effects on the TonenGeneral Group's business as a result of the dissolution of the joint venture and making NUC a wholly owned company are not expected to be material.
