This is to announce items pertaining to the status as Controlling Shareholder, etc., of Exxon Mobile Bay Limited Partnership, a major shareholder and other affiliated company of TonenGeneral Sekiyu K.K. (“the Company”).

2. Reason for acknowledgement by the Tokyo Stock Exchange of applicability of Listing Regulations Article 411, Section 3 to Controlling Shareholder, etc.

Exxon Mobile Bay Limited Partnership is a limited liability partnership.

3. Status of “Other Affiliated Company (Controlling Shareholder, etc.)” in corporate group

Exxon Mobile Bay Limited Partnership is wholly owned by Exxon Mobil Corporation. Exxon Mobil Corporation affiliates and the Company have concluded agreements pertaining to trademark licensing and business alliances regarding the manufacture and sale of lubricant products (including trademark and technical licensing); as well as agreements pertaining to licensing for technologies and intellectual properties regarding production of petroleum and petrochemical products. In addition, two employees of Exxon Mobil Corporation or its affiliate are currently serving as Directors of the Company. This does not hinder the Company’s independent decision-making processes.

4. Items pertaining to transactions with “Other Affiliated Company (Controlling Shareholder, etc.)”

There are no significant business transactions conducted by the Company with Exxon Mobile Bay Limited Partnership.
